### City of Grand Ledge is looking into expanding wastewater treatment plant into Fitzgerald Park

A Lansing State Journal article last week discussed a possible expansion of the Grand Ledge wastewater treatment plant into Fitzgerald Park, which could possibly cut the park in half, and have an impact on more than two miles of nature trails, 14 disc golf course holes, a pavilion, sledding hill, nature center and public restrooms on the west side of the park.

A group of concerned geoscientists from around the State quickly jumped into action by forming a Fitzgerald Park Geology Response Team. I believe Danita Brant and Michael Velbel (MSU) met with the Mayor of Grand Ledge and the City Administrator for a walk through of the park and discussed the importance of the Saginaw outcrops. They also discussed the city's re-development ideas. The Response Team will transition to a Geology Advisory Team and hopefully be able to give some insight to the re-development plans. Historically named after the decade of brick production that once took place on site, Lincoln Brick Park is located just north of Grand Ledge on Tallman Road one mile west of M-100 off of State Road. This 90 acre park is composed of a variety of habitats from woodlands and open meadows to over 6,000 feet of scenic river frontage.

The Interpretive Center at Lincoln Brick Park includes a museum and classroom meeting area with attached kitchenette. The museum area features a display on the history of Lincoln Brick Park and has a large collection of fossils and rocks from all over the United States. These facilities are designed for people of all ages; welcoming visitors and providing information and educational programs.

**President:** Nate Krupp called the meeting to order at 7:02 p.m. at the Okemos Public Library.
